You have been identified as a person who cancelled a Monthly Dues Membership at L.A. Fitness International, LLC (“LA Fitness”) during the period from May 18, 2006 through January 1, 2013. You may be eligible to receive benefits, including potentially a cash payment, from a proposed class action settlement (the “Settlement”) in the consolidated class actions *Kenneth J. Silver, et al. v. L.A. Fitness International, LLC*, No. 10-cv-2326-MMB; *Joshua Vaughn v. L.A. Fitness International, LLC*, No. 11-cv-2644-MMB; *Amalia Sible v. L.A. Fitness International, LLC*, No. 13-cv-0255-MMB, pending in the United States District Court for the Eastern District of Pennsylvania.

**Settled Claims:** The proposed Settlement will resolve Plaintiffs’ claims that LA Fitness failed to timely cancel certain customers’ Monthly Dues Membership Agreements after such members gave LA Fitness notice of their request to cancel the agreements and/or that LA Fitness improperly charged monthly dues after the member mailed a valid notice of cancellation to LA Fitness. The proposed Settlement will also resolve Plaintiffs’ claims that the terms, policies and contract forms for the Monthly Dues Membership violated consumer protection statutes and other state laws.

**Settlement Benefits:** The Settlement provides various benefits described in more detail in the Notice. All class members are entitled to receive a fully transferable 45-Day Club Access Pass valid at all LA Fitness Club locations, except Signature Club Locations. Certain class members may also be eligible for a cash payment equal to either one-third of one month of dues (if you meet the qualifications for Subclass “A”), or 50% or 100% of all dues paid for up to one year after a member mailed a cancellation notice to LA Fitness (if you meet the qualifications for Subclass “B”). If you meet the qualifications for Subclass “B” you may also submit a claim for a 60-Day Club Access Pass instead of the 45-Day Club Access Pass. You may also contact the Claims Administrator at the telephone number or address identified above.

**[You have been identified as a member of Subclass “A.” As a member of Subclass “A,” you may submit a claim for \$<<SubAAmt>> instead of receiving the 45-Day Club Access Pass. **Your Options:** If you wish to submit a claim for benefits under Subclass A or Subclass B, you must do so by **August 9, 2013**. If you wish to sign up for the 45-Day Club Access Pass, you must do so by **May 11, 2014**. If you submit a claim, or if you do nothing, you are bound by the Settlement and you will release any claims you may have against LA Fitness, as defined in the Notice and Settlement Agreement. You may exclude yourself from the Settlement Class by sending a letter to the Claims Administrator according to the instructions in the Notice, in which case you will not release any claims against LA Fitness. You may also object to the Settlement by following the instructions in the Notice, or you may exclude yourself from the Settlement Class by sending a letter to the Claims Administrator according to the instructions in the Notice. You must mail your Requests for Exclusion or Objections to the Claims Administrator at *U.S. Gym Settlement, Claims Administrator, c/o Gilardi & Co. LLC, P.O. Box 8090, San Rafael, CA 94912-8090* by **August 9, 2013**. A final approval hearing is scheduled for **September 19, 2013** in courtroom 3A of the United States District Court for the Eastern District of Pennsylvania.
